i. Lead [Pb] and Cadmium [Cd]:

The sample is comminuted and digested with acid mixtures. The contents of Pb and Cd are determined with ICP-OES technique. (Reference: Section 9, page 49)

- Mercury [Hg]: The sample is comminuted and digested with acid mixtures. The content of Hg is determined with ICP-OES technique. (Reference: Section 7, page 35)
- iii Chromium (VI) [Cr(VI)]:

The sample is comminuted and digested with alkaline mixtures. The content of Chromium VI is determined with UV-VIS spectroscopic technique. (Reference: Annex C, page 83)

 Polybrominated Biphenyls[PBB] and Polybrominated Diphenyl Ethers [PBDE]: The sample is first scanned by infra red (IR) spectroscopy and appropriate solvent is used for extraction. The contents of PBBs and PBDEs are determined by GC-MS. (Reference: Annex A, page 63)




