

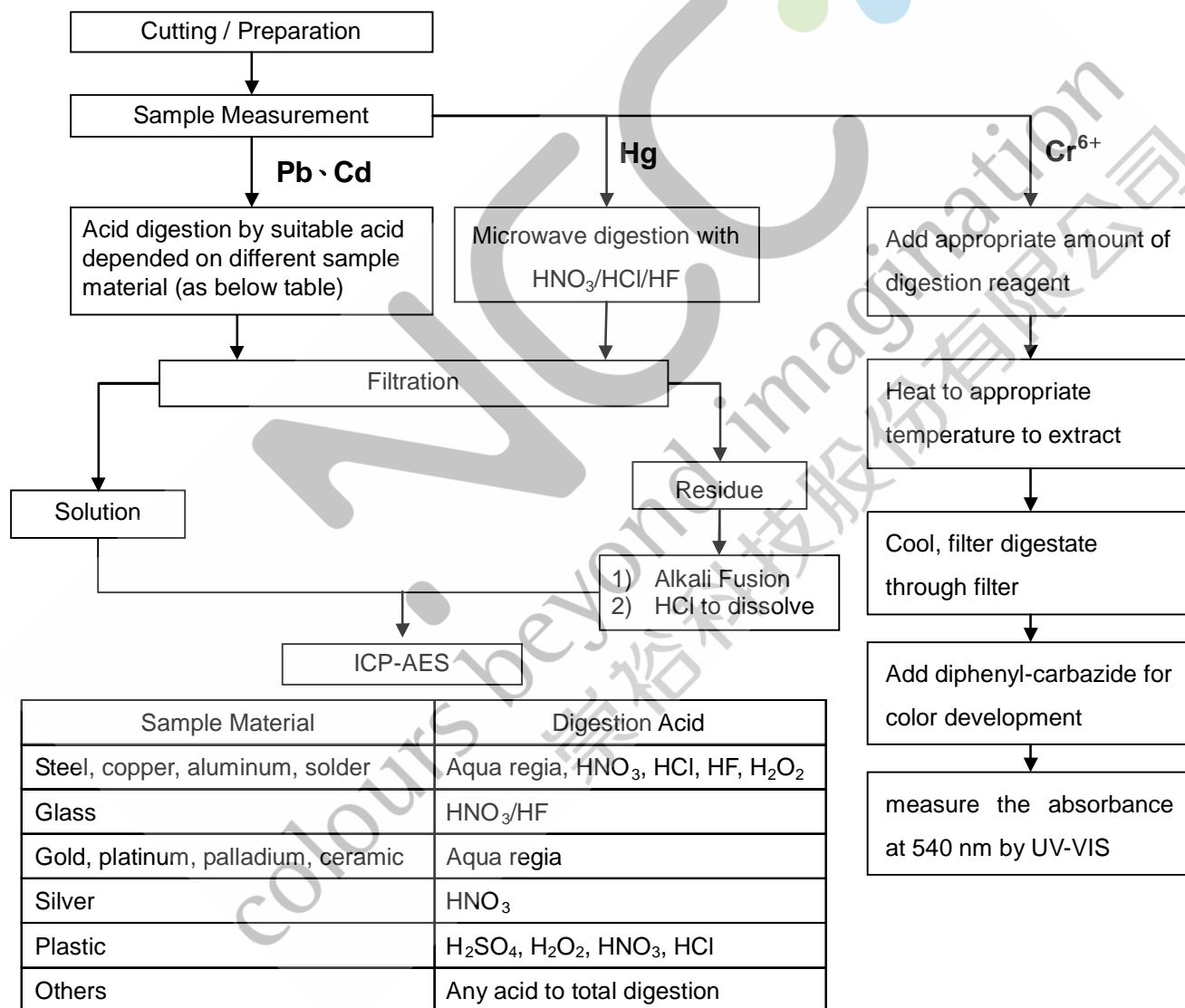

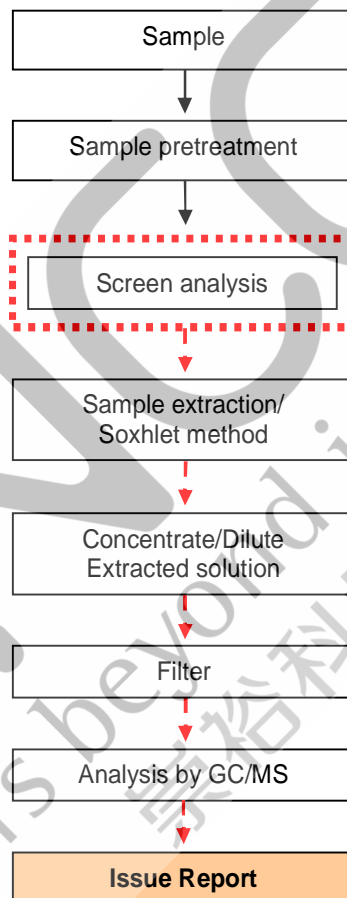
### PBB/PBDE analytical FLOW CHART
